

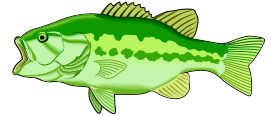

However, you must pre-order the fish through UUCF. Shiners are available at \$13.35 per dozen for Medium Wild Shiners and \$20.60 per dozen for Large Wild Shiners and must be ordered **no later than Friday, January 13, 2012**. Each team must submit the number of dozens that they will be using each day. If you do not pre-order your shiners through UUCF, they will not be available to you during the tournament.
